## **AA SERVICE WORK**

Since man started consuming alcohol, there have always been those whose relation to alcohol was different than his fellows. These individuals baffled their friends and family for their inability to control or moderate their drinking. In all that time, there have been two organizations that have helped a large number of alcoholics stay sober. The first was the Washingtonians, who in the mid-nineteenth century grew to nearly 600,000 members before it failed. Then, there was the organization that grew out of the meeting of a failed stock broker and a drunkard doctor in 1935, Alcoholics Anonymous (AA). These two societies shared one thing in common; they believed that one alcoholic could help another where no one else could.

In the Big Book, Bill Wilson's solution to almost every problem includes intensive work with another alcoholic. Thus, our third legacy of service was born. In his writings, Bill talks about the concept that any activity which helps bring two alcoholics together for recovery is service work. Anything from making coffee at a home group to serving on the General Service Board as a Trustee to answering a twelfth step call in the middle of the night is service work. We can only keep what we find in AA by giving it away. Another benefit is that when I started giving back to AA, I started to feel like I belonged in AA.

A strange correlation to that fact is that the same principles apply to the AA group. In the long form of the fifth tradition, Bill states that "Each Alcoholics Anonymous group ought to be a spiritual entity *having but one primary purpose* - that of carrying its message to the alcoholic who still suffers." Notice that Bill refers to a group as a spiritual entity; this implies that, just like the alcoholic, the group needs service to thrive. He also says that each group should carry ITS message, not THE message. Each group has its own experience, strength, and hope and needs to carry this message to others.

I have seen many different types of groups and I have seen numerous groups in AA come and go. As a friend of mine once said that, "AA members vote with their feet". When a group stops meeting the needs of its members, they go somewhere else. I have also noticed that the groups that attract me most are the active groups; their message seems to carry more depth and weight. Furthermore, these groups seem to practice the traditions in their affairs.
