## WHAT IS THE CSO?

There seems to be confusion about what the Central Service Office (CSO) is and what it does. The CSO of Southern Colorado was established to "primary purpose is to serve in support of Southern Colorado Groups of Alcoholics Anonymous (AA) in their common purpose of carrying the message to the alcoholic who still suffers." (CSO Charter) To accomplish this mission the CSO provides numerous services.

First and foremost, the CSO is the AA phone number in Southern Colorado. When someone calls AA, whether it is a request for information or a cry for help, the phone is answered in our office or by the answering service. In conjunction with this, we maintain a current 12th step list of people willing to help alcoholics calling for assistance.

Next, the office maintains an inventory of AA books, pamphlets, and sobriety coins to sell to the local AA community. We can also special order items for groups and individuals. There is also an archive of grapevines available for checkout.

Finally, we are responsible for keeping a list of all meetings in the southern Colorado region. The list is published and distributed throughout the area. It is also on our website (www.puebloaa.org). If you need more copies of the meeting list for yourself or your group, they are available at the office.

There is a misunderstanding about what a CSO is in relation to an intergroup. In AA service literature the 2 organizations are synonymous. They both have the same functions and both answer to the groups in their service areas. The CSO is run by a Steering Committee which is made up of elected members and representatives from the groups in the region. All groups are invited to send a representative to the monthly Steering Committee meeting on the first Wednesday of the month at 6:00 pm in the office. Both groups are also financed by contributions from groups and individuals in their areas. The only real difference is that some regions establish an intergroup and some a central office.
