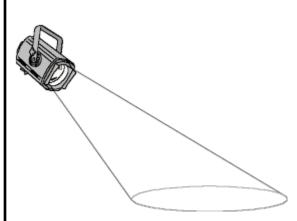

IN THE SPOT LIGHT



Relief versus Recovery. I don't know where this Idea came from but I do know it's not original to me. I haven't had an original thought in years. My best cute quips to say in a meeting are all stolen from somebody over the years. In the last newsletter I mentioned the constant need to review my behavior and dedication to practicing the twelve steps. The best this program has to offer is a new way of life. It begins with admitting powerlessness over alcohol. That is widely interpreted as not putting it in your body anymore. That is relief. When I started attending meetings I had back problems. My family was on my back, I felt the police were on my back, my employer was on my back. Quitting drinking would have got them off my back. When I finally quit drinking for good and all it was because I wanted recovery.

Recovery: This is a great time to be in AA here in Pueblo Colorado. There is a flyer circulating that is a special workshop in three parts being put on by the Primary Purpose Group. My home group, Joyful Journey has just completed a course of Back to Basics with a

Power-point presentation and a workbook assembled in the nineteen forties by one Wally P. That is an excellent guide to working the steps and following the program as laid out in the book of Alcoholics Anonymous. (The workshop is old, the power-point a recent addition.) We intend to do it on Wednesdays at noon, Quarterly. It completes the twelve steps over the course of four sessions so we go through them in a month.

There is a meeting every Monday at the Pueblo county jail for male inmates, you must be cleared by the sheriffs office to attend. Please have one year or more of continuous sobriety before volunteering. If you are interested please contact me by email at the address on the other side of this sheet. You may also contact the Sheriffs department directly. Their contact person is Deputy Jeff Stout.
