

# IN THE SPOT LIGHT

Here we are in the sixth month and there will be lots of talk on the sixth step. The Big Book says very little and focuses on what we have learned in the fifth step. The step says "we were entirely ready to have God remove all these defects of character." The language of the step brings up a number of questions. In the next step these defects are referred to as shortcomings. let's settle this one right now. In Bill's later writings he states that he was taught that good writing meant not repeating the same terms for an idea if there is another way to express it. He meant only to change the term not the

meaning. To the author of the book, there is no difference between a "defect of character" and a "shortcoming". The next question is, how do we work on something like the removal of defects? The answer is this, the step asks us to be "ready to have God remove" our defects. It does not say we will cast out our defects. It says that God will remove them. Our part is to be ready. That means that something like prayer and meditation, contact with a higher power is in order.

If we are to meditate on what kind of a change we wish to have come about, we should have a clear understanding of what we mean by defect of character. At this point we can switch from the Big Book to the Twelve Steps and Twelve Traditions. In this later book there is a lot more information about what a defect of character is. The easiest for most people to understand is that our behavior moves into the area of being defective when we let a natural instinct run out of control. The desire for security becomes greed, the desire for companionship becomes lust, the desire for recognition by our fellows becomes pride. This is but a partial list, but all these defects are based in fear. For myself, I have to meditate upon the questions of, what am I afraid of? Is this a valid fear? What if this did come true, how would it affect my life? In truth I have enough experience to know that the great majority of my fears are smoke and mirrors.
