AA and the Traditions By - Kevin W/Pueblo

I was in the US Navy for 14 years and it was said that Navy Regulations were written in blood. It took something bad happening to develop rules to prevent that from happening again. It is the same way in Alcoholics Anonymous, there were many problems and divisions in the early days of AA that hampered recovery.

The office in New York received many calls and letters concerning the problems AA members were having with their groups and the program. Bill looked at these problems and developed the 12 Traditions of Alcoholics Anonymous. A statement appears before the long form of the Traditions that reads, "Our A.A. experience has taught us that:" (Reprinted from Twelve Steps and Twelve Traditions, page 189, with permission of A.A. World Services, Inc.).

In Bill's writings, he uses the 1st Step/Tradition/Concept as a statement of the problem to be addressed. The following 11 statements are the solutions used to resolve these problems. In the case of the Traditions unity in AA is the issue that needs to be dealt with.

For AA to survive, we must work together toward a common goal. The remaining Traditions are the principles we should observe to ensure unity in the program. Bill wrote articles in the Grapevine discussing the proposed Traditions. The 12 Traditions were adopted in 1950 at the first International Convention in Cleveland. During this period, it was said that when Bill was asked to speak at a meeting they wanted to hear his drinking stories and not the Traditions.

The Traditions still are not normally discussed at AA meetings. I remember being at a meeting one time where the chairperson was reminded after starting the meeting that this was the day for the monthly tradition meeting. At this point a large portion of the attendees got up and left the meeting. This disdain for the Traditions is sad (my opinion).

Most of the time when I hear the Traditions used, it is as a weapon to attack someone or something. Normally, when used, it is out of context. An example of this is the use of the 4th tradition. I often hear it used as an excuse for a group to do something that is out of the norm. The group will say "but each group is autonomous", totally ignoring the second part, "except in matters affecting other groups, or AA as a whole" (Reprinted from Twelve Steps and Twelve Traditions, page 10, with permission of A.A. World Services, Inc.). In a recent situation where this came to play is when a government agency was sued because the individual was ordered to attend AA. Because AA was deemed to be a religion due to things like the bible being read at meetings, religious topics being discussed in meetings, etc. Because groups claimed to be autonomous, they affected other AA groups and AA as a whole.

I firmly believe that we should have actual Tradition studies where we can really learn the intent and meaning of the Traditions. I also think that groups should spend time reading the long form of the Traditions as there are some significant differences between the long form and the short form. Obviously I do not suggest the reading of the complete long form at every meeting, but dedicate some time to look at them.

A good resource that will help understanding the Traditions is the pamphlet, "A.A. Tradition-How it Developed" (P-17) which contains writings by Bill concerning the meaning of many of the concepts used in the Traditions. For more information, you can get a digital subscription to the Grapevine which gives you access to all copies of the Grapevine; you can also search online for videos of Bill talking about the traditions.
