A BRIEF HISTORY OF OCSOBERFEST IN PUEBLO

The first Ocsoberfest was in September of 1999. Some members of Pueblo AA went to a weekend gathering in Bullhead City, Arizona called "The Vigin River Roundup". The group included Frank W., Chris W. and John D. Chris was on City Council in Pueblo, and they were just finishing up Pueblo's new Convention and Visitors Center.

Upon returning to Pueblo the idea for a weekend gathering of Alcoholics in recovery was brought up at the area intergroup. There was no Central Service Office at the time. The District 8 committee was not involved because the organizing committee for the event wanted it to be a separate entity, and the funds were coming from an intergroup event.

The story of the seed money for the first Ocsoberfest is that someone paid back the intergroup a lump sum as part of a ninth step. The money was sitting in an account controlled by the intergroup. A group conscience was taken to give this surplus to the Committee to seed the Ocsoberfest.

The point being that Ocsoberfest would not be an AA event. People in other twelve step recovery groups could attend and participate.

The first Ocsoberfest would be the first event in the new Pueblo Convention center. John D. would be the first chairperson for the event, Frank W. would be the first treasurer, Chris W. would be the co-chair with the intent that he would chair the next event. The pattern of having chairperson and co-chair was intended to allow the co-chair to gain experience in how the process hapı

the following year. My recollection, which may be faulty, is that Frank W. was chair the next year.

All the original contracts with the Convention Center management group were negotiated by Chris. We were originally allowed to bring only homemade cookies to the event, and we were allowed to use their equipment but brew all our own coffee. Nothing was allowed that was pre-packaged and the pastries had to be clearly a cookie and not a roll or bread, no meat or cheese, no hot dishes. This part of the contract has always been an issue. Some later chairpersons suffered huge losses because of the Convention Center's management insistence on having all the food and beverages come off their menus at their premium prices for less than premium food.

The funds available at this time are not insubstantial, but considerably less than what we started with. There have been probably twenty different committees over the years, not counting the years we have had the State AA Convention. The bottom line is that the Ocsoberfest is not a normal AA meeting, it is considered a special event and has addition expenses to pay. It is a celebration of sobriety. Every effort is made to follow the traditions in their actions, but do not have to be as tightly bound to them as an AA group. Ocsoberfest is not free. There are groups in Pueblo that will provide scholarships for those who need help to cover the registration fees.

I don't remember all the people that have chaired and served on the committees over the years but I thank them all for their service.
